**Change of composition:** more than 60% first-time lawmakers; strong performance from right and far right political parties. A shift in power structures



**Change of agenda:** especially when it comes to the immigration, Green Deal, security and defence. But the EU not to accommodate shifts globally, instead steps to create and maintain its own position globally – greater strategic sovereignty for Europe



**President of the European Commission re-elected; new Commissioner for Defence:** strong and resilient EU, greater EU funding, joint procurement accompanied by 'buy European'

Mission Letters and Political Guidelines 2024-2029: more subsidies, more tariffs to protect EU domestic champions. Focus also on competitiveness, technology, industrial policy, and defence





# Strong headwinds against the multilateral rules-based system Trade



**Trade Defence Machanisms:** set to continue. More implementation and further amendments to render them even more fit for purpose.



**European Economic Security Strategy** will continue to be further developed, especially when it comes to dealing with outbound investments



**China:** The US expects the EU to align on China. Currently, a lot of talk of about de-risking in the EU, but in practice looking a lot more like de-coupling
